General Conditions of Membership

1. Gate Governors Club membership is a membership in two or more of Gate-owned clubs. A member is entitled to use only the clubs for which the initiation and membership dues are paid.
2. Membership cards are not transferable and may be used only by the member and eligible dependents. Loaning of membership cards is not permitted and may result in cancellation of membership.
3. Guests of a member must be accompanied by the member when using the club(s) unless prior authorization is granted by the Membership Department. Members may be subject to guest fees and shall be responsible for the bills and charges as well as the actions and conduct of their guests, including, without limitation, all costs, expenses and damages incurred or caused by their guests.
4. Membership cards must be presented when using any of the clubs' facilities.
5. Initiation fees and dues are non-refundable and are not transferable, and are subject to the appropriate sales tax.
6. Home Club Rule: The designated Home Club is the club (or clubs) originally joined and where initiation fees have been paid in full. Members may add a club to their original membership at any time by paying an "add on" fee. If at some future time the member decides to drop the Home Club, he will be able to retain the add-on club by paying the current initiation fee for that club less the amount paid at the time the member joined the Governors Club.
7. Each member will be provided with a "Member's Handbook" from the individual Clubs, which contains additional information regarding facilities, dues, fees, guests, dress codes, etc. Members are required to comply with the policies therein as well as the Governor's Club rules. The Club shall have the right to update, modify, and/or amend the Member's Handbook and Governor's Club rules from time to time.
8. Club bills are due and payable upon receipt. Accounts past due in excess of 30 days at any Club shall be considered cause for suspension, without prior notice, of membership privileges at all of the Gate Clubs. Failure to pay dues and/or Club accounts may result in expulsion from the Club. Members will also be liable for all costs and expenses of any legal action to collect accounts properly owed to the Club.
9. In the event of a divorce, the membership is decreed by court order. The remaining party may apply for his/her own membership within 60 days after divorce at 50% of current initiation fee(s). Dues will be prorated accordingly.
10. Members under the age of 35, qualify for a Junior membership (based on the oldest spouse, if married). Junior members pay half of the initiation fees now and the balance is due upon turning age 35. A driver's license(s) must be submitted for proof of age.
11. The Membership Department(s) must be notified immediately of any change of status to membership. This includes adding/deleting a spouse as a result of marriage or divorce, additional dependents, death of a member, employment changes, residence or phone numbers. Change/request forms are available in the membership office.
12. In the Club's sole discretion, membership may be suspended or canceled, without refund, if a Member or a Member's guest: (a) Violates Club rules and policies including the Membership Agreement, Member's Handbook, or the Governor's Club rules; (b) Violates any state, federal, or municipal law, regulation or ordinance while on Club property or during any Club-sponsored event, or (c) Engages in any wrongful, intentional, or negligent conduct or otherwise acts in any wrongful manner which may expose the Club to liability or is inappropriate or inconsistent with the Club's policies.
